To, my Nephew John P. Wilson I give and bequeath the sum of five hundred Dollars.

To John Adger & William A. Player I give & bequeath the sum of two thousand Dollars In trust for the Sole & separate use benefit & behoof of my sister Jane Anne Quigley during her natural life, & after her death to the issue of her body which she may leave living at the time of her death equally to be divided among them, and in the Event that the said Jane Anne should die leaving no issue of her body living at the time of her death. I give & bequeath the said sum of two thousand Dollars to my sister Agnes Law Quigley, for her sole & separate use benefit & behoof during her natural life, & after her death for the use of the issue of her body which she may leave living at the time of her death equally to be divided among them,

And if the said Jane Anne & Agnes Law shall both die leaving no issue of their bodies living at the time of their death, then the said John Adger & Wm A. Player shall hold & possess the said two thousand Dollars for the use of my sister Elizabeth M. Dargan .

I give & bequeath to the said John Adger & Wm A. Player the sum of two thousand Dollars In trust for the ~~the~~ Sole & separate use benefit & behoof of my sister Agnes Law Quigley for & during her natural life & ~~at~~ after her death for the use of the issue of her body which she may leave living at the time of her death, and if the said Agnes Law should die leaving no issue of her body, living at the time of her death, In trust for the sole & separate use benefit & behoof of my sister Jane Ann Quigley for & during the time of her natural life & after

leave living at the time of her death equally to be divided among them . And if the said Agnes Law & Jane Ann shall both die without leaving issue of their bodies living at the time of their death, then the said John Adger & Wm A. Player shall hold & possess the last mentioned sum of two thousand Dollars for the use of my sister Eliza Elizabeth M. Dargan If there should not be enough of my Estate to pay the said several legacies there must be a ~~proper~~ proportional abatement The interest on the legacies to Jane Ann & Agnes Law Quigley may be used for their benefit before they are twenty one years old if necessary.-----

I nominate & appoint John Edgar & Wm A. Player the Executors of this my last will & testament .-----
