MARY WINBERLY

IN THE NAME OF GOD AMEN I Mary Winberly of the County of Richland being very sick and of perfect ~~of~~ Body but of and of perfect mind and Memory thanks be given unto God Calling unto mind the mortality of my body and knowing that it is appointed for all Men once to die Do make and Ordain this my last Will and Testament that is to say principally and first of all I give and bequeath my soul into the hands of Almighty God that gave it and my body I recommend to the Earth to be Buried in Decent Christian burial at the Discretion of my Executors nothing Doubting but at the General Resurrection I Shall receive the same again by the mighty power of God and as Touching such worldly Estates Where-with it has pleased God to Bless me in this life I give Devise and Dispose of Same in the following manner and forms

I give and bequeath to Noah Winberly My Dearly beloved son All his cattle and A Mare and three ~~colts~~ and one that the mare is with fold with and one feather Bed & furniture.

I give to my well beloved Daughter Penelopy Neall all the Cattle that was called hire & the old mare and the hess colt that was call hire and one feather Bed and Furniture.

I give to my well beloved Daughter Catey Blanchard five pound sterling Out of the Note she is due from Mr. Whittier to me Mary Winberly.

I give to ^{my} well beloved Daughter Sarah Wells five pound Sterling Out of the Said Note that is due ^{from Mrs Whitiger} and likewise the rest of the Note to be Equal Divided Between Noah Winberly & Penelopy Neal and the power is to be divided Between Noah W--- Penelopy Neal and there is two Dollars to Abby Blanchard and two to Janiah Blanchard I likewise ordain this to be my last Will and testament My desire
