

IN THE NAME OF GOD AMEN.

I William Carroll of Richland District in the State of South Carolina being of sound and disposing mind and memory but weak in body, calling to mind the uncertainty of human life, do make and declare this to be my last will and testament.-----

I give ~~an~~ devise and bequeath to my son Arthur B. Carroll the tract of land whereon he now resides begining at the branch where Woodward's line ^{crosses} ~~crosses~~ it, and running thence along Isom Woodward's line to lands owned by Spann, but now occupied by Mrs Martha Grant, thence pursuing the line of the said tract to Dr Hamptons land, thence following the boundary of Dr Hampton's land to the branch on the East side of the tract now devised and thence along said branch to the beginning ; which land with the improvements thereon I devise to my said son Arthur B Carroll to him, his heirs and assigns forever.-----

I also bequeath to my said son a negro named Joe forever.-----

I give devise and bequeath to my daughter Unity Gray one hundred acres of land, the premises whereon she now resides, to her, her heirs and assigns forever.-----

the tract hereby devised ~~is~~ is to begin on the East boundary of the said premises, and to run West until it encloses one hundred acres, forming as square as near as may be-----

It is also my will and pleasure and I hereby bequeath to my Daughter the said Unity Gray a negro girl named Annika with her future encrease forever.-----

I give devise and bequeath to my daughter Rachel Addison one hundred acres of land, the premises whereon she now resides to her, her heirs and assigns forever,---- the tract herein devised to begin on the South side thereof on lands formely owned by Judah Barret and now by Jesse Killingsworth Senior thence to run North until it encloses one hundred acres forming a square as near as may be bounded on the East by the land hereinbefore devised to Unity Gray.-----

I further bequeath to my daughter Rachel Addison a negro girl named Ruth with her future issue forever.-----

I give and devise and bequeath to my son Arthur B. Carroll and his heirs forever in trust for my daughter Rebecca Sowden for her sole and separate use, not subject to the debts, contracts or control of her present or any future husband, sixty five acres of land bounded West by Griffin's Creek, North by land belonging to Gaffney, East by land belonging to Garner & South by land formerly belonging to Croft and herein before devised.- I do dire that the negro girl Amanda be sold by my Executors, and that out of the proceeds of the said sale they pay over to Arthur B. Carroll in trust as aforesaid one hundred dollars so as to make up to the said Rebecca the value of one hundred acres of land whereof sixty five acres have been above devised for her use.-----

I also bequeath to the said Arthur B. Carroll a negro girl named Judah, which girl together with the said sixty five acres of land and part of the proceeds of Amanda I give devise and bequeath to said Arthur B. Carroll in trust as above mentioned for the sole and separate use of my daughter Rebecca Sowden during her natural life, and after her death in trust for such issue of her body as may be living at the time of her death, without any further condition or limitation.-----

I give and bequeath to my son Isaac Carroll a negro man named Sam, a negro boy named Esau and a negro woman Dinah with her future increase to him and his heirs forever.-----

All the rest and residue of my estate real and personal not hereinafter inbefore devised and bequeathed.-----

I give and devise and bequeath unto my son Isaac Carroll and my daughter ANN Carroll and to my wife Rebecca Carroll for her during the life of the latter and at her death I devise and bequeath the same to Isaac and Ann Carroll aforesaid, their heirs and assigns forever.-----

If during my life I should dispose of the said sixty five acres of land hereinbefore devised to Arthur B. Carroll in

trust, it is my will and desire that the proceeds of the said sale shall go to the same uses as are prescribed in relation to the said land.

I constitute and appoint my friend John T. Warfield and my sons Arthur B. Carroll and Isaac Carroll Executors of this my last will and testament. In testimony whereof I have hereto set my hand and affixed my seal this 21st day of January 1835
