Carolina, being at present sick and afflicted in body, but of sound and disposing mind, memory and understanding, praised be God for the same, do make and declare this my last will and Testament in manner and form following that is to say, -----First I give to my beloved Wife Elizabeth my negro woaman Jemimah to wait on her during her life, and as it has pleased God to suffer her to be incapacitated by mental affliction to attend to any basness. I give or direct that she have the residue of her Thirds of my Estate in money to be carefully loaned out by my Executor herein after named and to be applied for her benefit as need may require, and also that he carefully attend to her being confortably estimated at his new residence or elsewhere during her life. After her Decease the remainder to be equally divided hetween my eight children or in case of death their bodily heirs, share and share alike .-----Second . As I have given to my three sons Philips. Adam F & William a Tract of land lying on Haman Harmon's Creek, which I bought of Martin Miller, valued by sworn appraesers as follows Viz. my Son Phillips part at \$1150 and my sons Adams Do. at \$1150 and my son William's Diat Siks \$1300, which respective sums, should they be more than a distributive or equal share, than each one to pay over to my daughters or their bodily heirs such surplus so that each of my children share and share alike, I also have given to my daughter Nancy & son in law James Kelley her husband one third part of a Tract of land on Harmon's creek and one third part of the same to my daughter Elizabeth and son in law John Bernhard her husband and also one third part of the same to my daughter Frances and her husband David Turnipseed my son in law each part valued(as above) at \$353 x331/3 ots. I have also given my daughter Katharine a negro girl named Mary Ann instead of 2333"33 1/3 uts. in moneyand I have likewise given to my daughter Mary & son in law

Third- My desire is that all my Real and personal property be sold after my decease as soon as advisable, and division made as previously directed. And I do hereby nominate, constitute and appoint my Son Adam F. Dubard Executor of this my last will and Testament in writing, whereto I the said William Dubard have set my Hand and Seal this 26th, day of January in the year of our Lord 1839.
