IN THE NAME OF GOD AMEN- I William Fitzpatrick of Richland County in the State of South Carolina, being weak in body and low in State of health, but sound and perfect in mind memory and understanding, thanks be to Almighty God- but calling to mind that all men are appointed once to die, and therefore considering that my stay in this world may be but transitory as to what worldly estate with which it hath pleased the Almighty to bless me in this life- I give devise and bequeath the same in the following manner Viz First and principally I give and recommend my Soul to the Almighty God who gave it me, and my body I recommend to the Ground to be buried in a Christian decent manner, nothing doubting but that I shall receive the same again at the general resurrection through the mighty power of God- 2ndly- I will and direct that my just debts be paid - 3dthly I give and bequeath to my dearly beloved friend Elizabeth Gillaspee part of the furniture in the house I live in that belongs to me- also my Kitchen furniture and the following Negroes Stephen & Marie and their three Children Jenny Poledere and my Man Will and Son (Call Watts) Naro, Hannah Sharper & Pattey & Essex Sixteen Cows and Calves and four good horses to her and her heirs and assigns forever, in lieu of her acct against me for her several years service and the work of her negroes- 4thly- I give and bequeath to my dearly beloved God Son William G. F. by me adopted a full confirmation of the Deed given him in the State of Georgia with the delivering of ten Negroes also the following Negroes Morris, Nelly and their Children John Josey and Bettey Peggy & Tom (call Govan) An August and Phebe and my two, a bay filley and bay mixed with Gray Colt purchased of Col Wade Hampton also two hundred Dollars out of the balance of my Estate to be paid him yearly for ten years, or to his Guardian for the time being for Schooling boarding etc 5thly- To my married

I do hereby nominate Constitute and appoint my beloved friends Elizabeth Gellasbee James Chesnut and Daniel Peak with my Son Richard Fitzpatrick added after he comes to the age of maturity, to be Executors of this my last will and Testament, and Guardians of the persons and Estates of my Children until they respectively come of age themselves or be married, hereby revoking, disannulling and disallowing any former will by me at any time heretofore made, declaring this and this only to be my last will and Testament-----
