I Commit my Soul to God in Hopes of obtaining Mercy thro' Christ for all my past Sins and Wickedness, and Body to the Earth to be Decently Interred at the Discretion of my Executor here after mention'd and for what worldly Good it hath pleased God to bless me with in this life I give and bequeath the following manner

Imprimis it is my Desire that all my Just debts shall be paid.

2^{dly} I give and bequeath unto my Son Henry Fox the sum of Two hundred Dollars // 3^{ly} I give and bequeath unto the children of my late daughter Ann Scott the Sum of one hundred Dollars to be Equally to be Divided among them 4^{thly} I give and Bequeath unto my Daughter Unity Carter and her heirs the sum of Two hundred Dollars 5^{thly} I give and bequeath unto my Daughter Mary Powell and her heirs the sum of one hundred Dollars- 6^{thly} I give and bequeath unto the two children of my Late Daughter Eliz. Killingsworth the sum of Two Hundred Dollars Each to be paid by my Executors unto them when they shall obtain to the age of twenty one years. Lastly I give and Bequeath unto my two Sons Elijah and Elisha and their theirs for Ever all my Personal Estate consisting of Negroes Cattle Horses Hogs etc. Likewise all the Lands that I may Die Possessed of Houses and Household furniture I give and Bequeath in the manner unto my two said Sons and their heirs for Ever. The said Personal and Real Estate to be Equally Shared among my Said Sons And I do nominate and appoint my Son Henry Fox and Robert Carter Execu^s of my last

Will and Testament Revoking all other wills acknowledging this
only to be my Last will and testament- In Witness whereof I
have hereunto Set my Hand and Seal this 13 April 1808.

am sick and expect to dy. but am in my sound mind & senses
after commanding my sole to almighty God through the merits
of the Lord & saviour Jesus Christ and my Body to be deacently
buried at the discretion of my Executors I do make & ordain
this my last will & Testament----- Item after my funeral
charges & all my just debts are paid, I will that all my
property ~~as~~ real & personal be Kept to geather for the use
of supporting raising & schooling my beloved Children, until
my Youngest Child Maryan comes of age then to be equally divided
among all the surviving heirs of my Body legally begotten by
me-- Except my Beloved Daughter now Catharine Rayford to whom
I have already given which she has or has had in possession a
negro woman named Hannah & a Boy named Tom which said two negroes
I will that they be apraised what they was worth when I gave
them into her possession & the amount to be a part of her
Legase at the time of the devision. Item I will that if either
of my Children dy before the devision of my Estate takes
place leaving a lawfull Eshue that or they shall inherit thier
fahters or Mothers part-- Item I will & autherise my hereafter
named Executors if they think best to do so for the benefit
of my Children to sell all or any part of my Lands & purchase
other Lands with the monies where or in what Country they may
think best for the use above mentioned-- I do Nominate &
appoint my beloved Son Peter Macdonald and my friend Archelaus
Watkins to be my Lawfull Executors - this the twenty seventh
day of December the year of our Lord & Saviour Jesus Christ
1816 and in the forty first year of the Soveranety & Indepen-
dency of the Unighted States of America-----
