In case of the death of either of his childring's without an air lawfully got or begotten of his or there body it is my desire that his share should then be given to the surviving heir

I give and bequeath unto Jacob B. Higgins January Charrity.

Benjamina. Jane and Mary to be enjoyed by the said Jacob B. Higgins. the term of his natural life and it is my desire that upon said Jacob B. Higgins ceasing to be that such and such property as aforesaid shall belong to his childring - and I do hereby give and bequeath the same to the lawful heirs of his body forever

In case of the death of Either of his childring's dying without an air lawfully got or gatt begotten of his or there body it is my desire that there share should then be given to the surviving heirs.

I give and bequeath unto Sister Sarah Bathony's heirs five dollars to be enjoyed by them .

I give and bequeath unto Brother James B. Higgins Five Dollars to be enjoyed by him - I give and Bequeath unto Sister Mary Harris five Dollars to be Enjoyed by her.

I give and bequeath unto Brother Abraham B. Higgins five Dollars to be enjoyed by him--- I give and bequeath unto Sister Margaret Woods heirs five Dollars to be enjoyed by them-----

I give and bequeath unto Sister Catharine B. Holladay Five Dollars to be enjoyed by her.-----

Higgins the plantation where I now live and my old place where I formerly lived all the land that lies on the West of Also's old field and on to the East side of the field Also's old ~~field~~ Striking a line across the North East side of the Also old field to be enjoyed by the said William Higgins Junior the term of his natural life, and it is my desire that upon said William Higgins ceasing to be that said plantation and land aforesaid shall belong to his childring and I do hereby give and bequeath the same to the lawful heirs of his body forever-----

in the year of our Lord one thousand Eight hundred and forty
