discretion of my Executrix's nothing doubting but at the
General resurrection I shall receive the same again by the
mighty power of God.-----

And as touching worldly estate wherewith it has pleased God
to bless me in this life. I give demise and dispose of the
same in the following manner and form-----

First I give and bequeath to my daughter Ellis Dent. my Boy
Isaac and my woman Betsy and my Boy Frank and my girl Harriet
to remain in her family as long as they shall live and that
my said daughter Ellis shall at my and my wifes decease shall
give to my daughter Rebecca Dent that is If the said negroes
are alive and in health Nine hundred Dollars, And my daughter
Ellenor Wages nine hundred dollars, But if any of them should
be dead or diseased a reasonable deduction shall be made ----

And that the said Samuel Dent for Ellis Dent his wife Immediately
by afetr my decease shall take into his possession as above

stated the following three negroes Viz Isaac Boy Frank A Boy
and Harriet A girl - and the said Samuel Dent shall pay annually
two hundred dollars to ne put upon Interest until the decease
of my wife, Who is to remain on the place whe e I now live.

And she is to have the woman Betsy as long as she lives, and
at her decease the said negro woman is to go to Ellis Dent and
all my personal estate shall be sold Immediately afto my
decease and the money put upon Interest and my wife supported

out of the annual Income of my estate -And at my wifes decease
all my real estate shall be sold and an equal division be made
Also I give my three Children Viz Ellis Rebecca and Elenor
whom I likewise Constitute make and or dain the sole Executrix
of this my last will and testament all and singular my effects
by them freely to be possessed and enjoyed and I do hereby
utterly disallow revoke and disannull all and every other
former Testaments wills legacies bequests and Executors by
me any wise before named willed and bequeathed ratifying and
confirming this and no other to be my last will and Testament
in witness whereof I have hereunto set my hand and seal this
Seventh day of November in the pear of our Lord One thousand
eight hundred and fifty - and the seventy fifth year of the
Indenpendence of the United States of America .-----
