Bagwell, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William Harper all that lot or parcel of land lying in the County of State aforesaid, on the East side of the public road leading by Glendale, and lying between J. A. Brown and Col. W. H. Bagwell's lots. Beginning at a stone on the east side of the road. Col Bagwell's corner, and running thence N. 11 E., 1.13 to a stone, 3+ on road; thence N. 32.5 E., 1.05 to a stone 3+, east side of road; on Brown's line; thence with Brown's line S. 75.5 E., 2.63 to a stone, 3+ in old field; thence S. 10 W., 1.13 to a stone 3+ on Col. Bagwell's line; thence S. 86 W., 3.16 to beginning corner, containing Four Hundred and Seventy five thousandths 475/1000 acres, more or less.
