 Know all men by these
 presents, That I Mathew L. Bishop of Spar-
 tanburg County in the State aforesaid for
 and in consideration of two hundred dollars
 to me paid in hand by Mary A. Bishop of
 the County and State aforesaid have granted,
 bargained, sold & released and by these presents
 do grant, bargain, sell, and release unto the
 said Mary A. Bishop one lot land lying
 and being in the County of Spartanburg at
 Dorman Fork on the line of the Spartanburg
 and Ashville Railroad beginning on a stake
 one hundred feet from center of said Rail-
 road and on line of Street leading West
 from said Depot thence S $54\frac{1}{2}$ W 5 chains to a
 stake; thence S $35\frac{1}{2}$ E 4 chains to a stake; thence N $54\frac{1}{2}$
 E 5 chains to a stake; thence N $35\frac{1}{2}$ W 4 chains to
