Justice, of the County of Spartanburg, in the State aforesaid, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lula Justice, all that tract of land, lying being in the County of Spartanburg, on branch of Holston creek, water of South Pacolet river, and on both sides of New Cut road, beginning at a Post Oak stump on North side of said road, and running thence $88\frac{3}{4}$ E 47.3° chains to a stake, thence N 36.50 chains to a stake, thence $88\frac{3}{4}$ W 46.50 chains to a Post Oak stake; thence S 82 W 13.50 chains to a stone, thence S 10 W 10 crossing New Cut road 73 chains to a stake, thence S 79 E 16.3° chains to a stake; thence North 48 chains to the beginning corner, containing Two hundred and Eighty one acres the same more or less.
