Lipscomb, of Spartanburg County, in the State aforesaid, I have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Mr. C. Lipscomb a certain tract or plantation of land situated in the State and County above mentioned, on branches waters of Towcher Creek, being known as Lot No. 6 of the Wright land, beginning and running as follows: On a St 3 x 0 on Mr. C. Lipscomb's former lands, running with said land S 35 1/4 W. 27 to St. 3 x 0; thence N. 61 1/2 W. 24 to Poplar; thence S. 62 E. 30. rock on Mr. C. Lipscomb's line; thence with said line to the beginning, containing Seventy-five and 1/2 acres, the same, more or less, bounded by the Campbell land, Lot No. 5 of my Ellis Wright land and the Mr. C. Lipscomb land.
