Wm High of Spartanburg County in the State aforesaid, in consideration of the sum of Two Thousand Dollars to me paid by Orange Collins of Spartanburg County in the State aforesaid, have granted, bargained, sold and released, and do these presents, do grant bargain sell and release unto the said Orange Collins, That tract or parcel of land known as Lot No. 1 of the Crawfordville Tract, lying between the Magent road and James Creek branch of North Sugar river and bounded by lands of J. S. Coan and lots No. 2 and 3 of said Crawfordville Tracts, and containing fifty two, i.e. (52 1/2) acres more or less - said land situated, lying in the County & State aforesaid, together with all and singular the rights, members, hereditaments and appurtenances, to the premises belonging or in any wise incident or appertaining, do have and to hold all and singular the premises before mentioned, unto the said Orange Collins, his heirs and assigns, forever. And I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Orange Collins his heirs and assigns, against me and my heirs, and all other persons lawfully claiming, or to claim the same, or any part thereof.
