South of Henry Street, and East of Greenville Street
it being a portion of the lands formerly owned by said
Milnor Jones, and is fully set forth in a plat of said land
made by R. O. Lamm, Surveyor, and to which reference
is hereby made. The lot hereby sold is the following to
wit: The lot known as Lot No. 1, beginning at a stake
intersection of Henry Street and Exchange Street, and
running south Exchange Street, 50^{ft} E 187^{ft} 7ⁱⁿ feet to a
stake in Alley, thence N 68^{ft} E 66^{ft} feet to a stake in
said Alley, thence N 20^{ft} W 187^{ft} 7ⁱⁿ feet to a stake in

have granted, bargained, sold and released and by these presents
do grant, bargain, sell and release unto the said Martha J.
Thomson, all the following lot of land lying within corporate
limits of the City of Spartanburg, in said State lying South
of Henry street, and West of Greenville branch, it being
a portion of the lands formerly owned by said Wilmer
Jones, and is fully set forth in a plat of said lands
made by W. C. Lamm, Surveyor, and to which reference
is hereby made. The lot hereby sold is the following
to wit: Lot 3, beginning at a stake on Greenville
branch, and running N 85 1/2 W 9.50 to a stake on new
road, thence with said new road N 2 3/4 E 3.15 to
a stake, thence N 85 1/2 E 9.28 to a stake on East
side of said Greenville branch, thence down said
branch to the beginning containing Four & 1/2 acres
