Bruce of the County of Spartanburg, in the State aforesaid, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said W. B. Bruce, all that certain portions, parcels or tract of land, situated, lying and being, in the County of Spartanburg, and State aforesaid, on both sides of the Lyod join road, and known as a part of my home tract, having the following meets & bounds, corners and distances to wit: Beginning at a stone 37 in Mill road, and running thence with said road N 84° W 67.1 to a stake in said Lyod join road, thence S. 81° W 8.23 to a stone 3x, thence S 16 3/4 E 4.96 to a stone 3x; thence S. 81 1/2 W 10.13 to a Porcupine 3x thence S. 79 3/4 W 16.85 to a forked Red oak 3x, thence N 14 1/2 W 28.65 to a White oak 3x 3x thence N 43 1/2 E 7.90 to a stake 3x, thence N 64 E 13.95 to a stake, thence S 13 1/2 E 9.40 to a stone in field, thence N 99 E 29.88 to a stake, thence S 15 1/2 W 10.83 to a stone in field, thence S 86 E 2.72 to a stone in said Mill road, thence with the direction of said road S 6 1/2 W 10.97 to the beginning stone, and bounded by lands of said W.
