For all to whom these presents shall come, or be made known, or whom the same may in any way concern, I, Geo. W. Nicholls, Judge of Probate, of the County of Spartanburg, in the said State, send greeting:

Whereas, Amy S. Walker, Administratrix of the estate of ~~Wm~~ Walker, deceased, on or about the tenth day of February, in the year One Thous and Eight Hundred and Seventy-nine, did exhibit her Complaint in the Court of Probate, in the County of Spartanburg, and State aforesaid, setting forth that the personal estate of her intestate, the said ~~Wm~~ Walker, deceased, was utterly insufficient to pay his debts, &c., and asking that the real estate be sold in aid of assets, and the cause being at issue before the honorable Court aforesaid, came on to be heard on the 5th day of May, One Thousand Eight Hundred and Seventy-nine, when the said Court, after a full hearing thereof, and mature deliberation in the premises, did order, adjudge and Decree that the lot of land hereinafter mentioned and described, should be sold at public auction, by the Judge of Probate of Spartanburg County, on the terms, and for the purposes mentioned in said Decretal Order, as by reference thereto, on file in the said Court, will appear. C. Oliver. Frank Walker, who bid off said lot for One Hundred and Fifty-five Dollars, he being at that price the highest bidder for the same, having transferred his bid to the said R. C. Oliver.

Nicholls, Judge of Probate as aforesaid, in consideration of the premises, and also in consideration of the sum of One Hundred and fifty-five Dollars paid me by the said R. C. Oliver, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. C. Oliver, and his heirs and assigns, all
