In now all manner of witness,
that I Thomas M. Ray of Spartanburg County
in the State aforesaid, for and in consideration
of the sum of Five Hundred and Sixty Six Dollars
to me paid in hand paid by W R & E O Gaston of
Spartanburg County in the State aforesaid,
have granted, bargained, sold, and released,
and by these presents do grant, bargain, sell
and release unto the said W R & E O Gaston all
that tract or parcel of land situated lying and
being in the State and County aforesaid, on the
East side of the Georgia Road, and on the Head
waters of Ferguson Creek, Waters of South Tyger
River, Beginning at a stake on the north side of
the Georgia Road W 80 deg corner, and runs S 66
E 3640 to a Hickory in Burnette line, thence S 27 M 3800
to a small pine 3x, thence N 88 M 8.80 to a Rock 3x,
thence N 8 M 23.37 to a Red Oak 3x, thence N 25 M 16
ch to a Stake, thence N 67 M 14.20 to a Stake by
said Road, thence with the said Road to the
beginning corner, containing security Eight acres
more or less, adjoining lands of J O Johnson,
Willis Smith, Wilson Ray, and others. Together
with all and singular the rights, members,
dutaments and appurtenances to the said prop-
erty belonging, or in anywise incident or ap-
pertaining; To have and to hold all and
singular the premises before mentioned unto the


