at Ford, on Fair Forest creek, and running N
47° 5 to a bend in road, thence N 61° 35' 50 to a stake
in road, thence N 48° 25' 30 to stake on road,
thence N 15° 40, to a Persimmon bush in place of
Piercher, thence S. 49° 27' 00 to a N. 37° 37' 37, thence
S 39° 10' 6.50 to a Poplar 37° 37; thence S. 46° 10' 35.50 to a
