County in the State aforesaid, I have granted,
bargained, sold, and released, and by these
presents do grant bargain, sell and release
unto the said Lucy L Butler all that lot or
parcel of land lying and being in the City
of Spartanburg and State of South Carolina
and bounded on the East by Church Street, on
the South by lot belonging to Sarah E Stone
on the West by lot belonging to Jas. L. Erwin
and on the North by lot belonging to Charles Moore.
Said lot being a portion of the Homestead
lot on which I now reside, and fronts
on Church Street Fifty feet (50 ft) and running
back Two Hundred and Forty (240 ft) containing
