Bright, of the County of Spartanburg, in the State aforesaid, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. J. Bright all that certain portion, parcel or tract of land situated, lying and being in the County of Spartanburg, and State aforesaid, on both sides of the North Fork of Eggar River, and known as a part of the T. Montgomery lands. Beginning at a Division near the road, and running thence N. 80 W., 11.34 to stone 3 x; thence S. 42 E., 11.50 to stake; thence S. 5 W., 2.00 to Poplar 3 x; thence S. 75 E., 4.10 to a stone, 3 x; thence S. 53 E., 4.00 to a stone on road; thence S. 68 E., 8.80 to a stone, 3 x, on Cleveland's line; thence N. 25 E., 11.25 to Dogwood, 3 x; thence N. 35 E., 13.05 to a stake, 3 x; thence up the river to the mouth of Branch, and thence with Branch about 4.00 in all to an oak, 3 x, Morgan's corner; thence N. 41 W., 15.75 to a stone, 3 x; thence S. 67 W., 6.50 to a stone, 3 x; thence S. 17 E., 5.90 to a stake; thence S. 44 W., 2.60 to a stake; thence S. 35 E., across the river, 1.05 to a stake; thence S. 30 W., 13.28 to the beginning corner, containing Fifty-five acres, be the same more or less.
