of the sum of Two hundred and one fifty dollars, to me paid
by J. P. Rollins, of the County of Spartanburg in the State
aforesaid, have granted, bargained, sold and released and
by these presents do grant, bargain, sell and release unto
the said J. P. Rollins of the same State and County a certain
piece or parcel of land, situate in said State County,
and on both sides of Penn's Ford, road and branches of
Buck Creek, west of Pacolet river, beginning at a pine
thence with the H. C. Ferry line, 438 to 23.45 to a stake on
North Carolina line, thence with said line 187, 1145.40
to a Black Oak, thence with the lands of James R. Scott,
23.84, 23.25 to an Oak stump, thence with Andrew
Neavis line, 869 to 19.83 to the beginning, containing
Sixty four and one fourth (164) acres, more or less.
Together with all and singular her, successors, humiliti-
ments and appurtenances to the said premises belonging
or in anywise incident or appertaining; to have and
to hold all and singular the premises before
