

In the Name of God, Amen. I Henry O'Neill of the District of Spartanburgh and State of South Carolina planter, being low in health, but of sound mind memory and Understanding praised be God for the same: And Calling to mind that it is appointed for all men once to die, do make this my last will and Testament in manner and form following. Viz.

Imp—I recommend my Soul to God who gave it, and my body to the dust from whence it came, to be decently buried at the discretion of my Executors herein after mentioned, And as for such worldly goods as I am blessed with/ After my just debts and funeral Charges are paid./ I give and bequeath in manner and form following. Viz.

1st I lend to my beloved wife Hannah during her natural life or widowhood, the tract of land whereon we now live— My Negro Man George, my Negro woman Courtney, my Household & Kitchen furniture, a Horse bridle & Saddle of the value of one hundred dollars, two Cows & Calves, two Sows & pigs of her own Choosing, thirty barrels of Corn, farming Utensils sufficient to make a Crop & two hundred & fifty pounds of Bacon, but after her decease or marriage, all the property wll'd to her which may not be consumed I desire the same should be equally divided/except such as is hereafter excepted./ amongst all my Children—My Negro man George I hereby give the Saturday in every week during his life to labour for himself as a consideration for his fidelity to me, heretofore, his time to commence after the death or marriage of my said wife.

2nd I give and bequeath unto my son John O'Neill after the death or marriage of my said wife the tract of land & plantation whereon I now live to him and his heirs forever. Also give him at my decease my Negro Man Cato my Negro boys Frank, Owen & Silver wathh, which Negroes and watch I value to eleven hundred & thirty five dollars, to him and his Heirs forever.

3rd I lend unto my daughter Nancy Love my Negro girl Hester, my Negro girl Beth & negro boy Dave, during her natural life, but

fully begotten forever: which negroes I value to one thousand & Seventy dollars.

4th I give and bequesth unto my grandson Henry O Neill Love fifty dollars.

5th I lend to my daughter Mary Wingo during her natural life life, my Negro girl Sook & old Owen, But after her decease, my will is that the negroes left her & their Increase, be equally divided amongst the heirs of her body lawfully begotten forever, which negroes I value to eleven hundred dollars.

6th I lend unto my daughter Hannah Wilson during her natural life after the decease of my wife my negro man George, my negro woman Courtney & Child Amey, & Negro girl Lucy; But after the decease of my said daughter Hannah, my will is that the said negroes & their increase be equally divided amongst the heirs of her body lawfully begotten forever, still reserving to my negro man George the Saturday in each week to labour for himself during his life after the death of my said wife--The Value of which Negroes I estimate at Twelve hundred dollars.

7th The reason why I have set a price on each lot of negroes will's to my Children, is for the purpose that where the Valuation of either should fall short of the highest, that they shall receive of the rest of my estate a sum equivalent to the highest lot or Valuation.

8th After my will is complied with as aforesaid my desire is that the remainder of my estate of whatever nature is that the remainder of my estate of whatever nature or kind soever, should be equally divided amongst all my said Children by my executors.

Lastly--I do hereby nominate Constitute and appoint my trusty & worthy friends Zachariah McDaniel & John McDowell Executors of this my last will & Testament hereby revoking and making void all and every other will or wills at any time heretofore by me made, And do declare this to be my last will & Testament --In witness whereof I the said Henry O Neill hath hereunto set my
