I Give to my beloved wife Marget Walker Her Maintinance on the plantation whereon I now live Which Land I Give to my Two Sons John Walker & absalom Walker all the West part of my Land as far Down Tyger river to the Mouth of a Branch Called the Distell Branch then up said branch untill it Crosse the North line of sd Tract I also appoint my Two worthy neighbours W. John Mullinax & Mr. John Windman my Trustees of said Land untill my above named Children John walker and Absalom walker arive to the age of Twenty one years of age and also to see that my Said wife Marget Do receive a Just mentainance from the use of said Land I give to my Son Samuel walker the Ballance of Said Tract fr m said Destill Branch to the East of sd. Tract with Exception that he shall not sell the same Except to one of his Brothers I give to my Two Sons William walker & David Walker my Negro Woman named Salley & child Jack To be sold and Equally divided Between them the Said william & David walker I give to my wife Marget and my four Daughters Sabra, Marget, Nancy & Rebecca Walker one feather Bed & furniture one Cow and Calf to Each & Each of the Daughters part to remain in the hand of my said wife untill Each of my said Daughter arive to full age or Day of Marriage the Crop of Wheat now on the Ground after the --- Mentainance of the family is Taken out to be Devided Equally Between my f ur sons william, David, John & Absalom walker I Request my Executrix and Executor may sell after the

all my personal property which is not Mentioned Above and David
the amount arising therefrom Equally Amongst my wife Marget
walker & ~~four daughters~~ all my Sons & Daughters William walker
Samuel walker David walker John walker & absalom---Elizabet
Vere Sabra walker Marget walker Nancy walker & Rebecca wal er"
