I Recommend my soul to God who gave it, And as for my Body, I Recommend it to the Earth to be buried in a Christian manner at the Discretion of my Exe. hereafter Named- And as touching such worldly things, wherewith it hath pleased God to bless me with in this life, I Dispose of in the Manner as follows.

Charges be first paid out of my Estate-~~

Item. It is my will I do allow my beloved wife Mary Frie her bed and furniture and also the bay mare and black mares colt and Black cow and her calve and also a cow and her calve that I bought from Vincin Roman; It is my will I do allow my beloved wife Mary Frie her widowhood the big pewter dish and dozen Delf plates one tin bucket and one tin Coffee pot and one tin Canister four new tin cups and one large pot and the Small dutch oven and also one New chest the newest chest we have but if the said Mary Frie should Mary. I do Allow those Articles before Mentioned which. I. Allowed her Widowhood to be sold and Divided Equally Betwixt my four Children. to wit William, Barbara, Gilbert and Tartleton-----

It is my will and I Allow my son William Frie one Black horse and one pair of hams and one pair of iron traises and one swingletree and a big bar shear plough one ax and my saddle and one no horned Cow and her calve and also my Coopering Tools the Remainder of my clothes I allow to W. P. after Gilberts and ta. suit-----

It is my will and I do Allow my Daughter Barbara Frie one black colt one brindled cow and her yearlin and also her bed

and furniture and one big Dutch oven and one pewter dish and
four delf plates and one small spinning wheel and also the old
chest. It is my Will and. I. do Allow my son Gilbert ^{frie}
the upper part of the plantation which I am now living on
beginning on a haw bush that is standing on the Conditional
line betwixt ^{wm.} Abrahams and myself or near to the line and
turning up the hollow through the field and thence ~~thence~~
