Item, I, Give, and devise unto my brother Abner Benson, all
my part, of a certain Tract of land, purchased by him and
myself of Edmund Bishop, Containing three hundred acres more
or less - lying in the District of Spartanburgh on Lawsons
Park, also/one other Tract of land purchased of George Hughes
by him and myself - adjoining the Tract aforesaid, also/
a Tract of land purchased by him and myself from James
Templeton containing five acres more or less, - Also/one other
Tract of land purchased by him & myself from James Templeton,
containing Two hundred and Ten acres more or less. Also,
my part of a lease of a Tract of land, leased from the heirs
