State of South Carolina) In the name of God Amen, I Alice Terry of
Sumter District-----) the State and District aforesaid, being
weak and frail of Body, but sound of mind and calling to remembrance
the mortality of my body, do make and declare this my last Will and
Testament, as touching such worldly property as it has pleased God
to blesse me with----I give, Bequeath and Devise of the same in man-
ner and form following.-----

First, It is my will request and order that all my just debts
be first of all duly paid and fully discharged-----Then-----
I give and Bequeath to my beloved Daughter Mary Wells Two Negroes
by the name of Phillis and Zebulon to her and the Heirs of her body
forever, provided, that there shall be no debts brought against me,
or my Estate from the estate of John Wells deceased, then , and in
that case, the aforesaid Negroes, Phillis and Zebulon, are to be
valued & to pay said debt, and the ballance to go to my daughter
Mary Wells & her Heirs forever.

I lend to my beloved Son Joham Terry Two Negroes by the Name
of Tom and Nancy during his natural life, and at his death I give &
bequeath the said Two Negroes, Tom & Nancy, to his Son Matthew Will-
iam Terry during his natural life, and provided he the said Matthew
William Terry hav lawfull Issue I give it for ever, but otherwise,
to return to my Estate & to be divided amongst my heirs forever,
share & share alike-----

I give and bequeath to my dear grandson James Terry--Dukes,
One Negroe boy by the name of Dave, to him & his Heirs forever, but
should the said James Terry Dukes not live to have lawfull Issue
then the said negroe Dave to return to my Estate and be divided be-
tween my Heirs, share and share alike-----

I give and bequeath to my dear grandson James Terry--Dukes, One Negroe boy by the name of Dave, to him & his Heirs forever, but should the said James Terry Dukes not live to have lawfull Ifsue then the said negroe Dave to return to my Estate and be divided between my Heirs, share and share alike-----

I give and Bequeath to my Beloved daughter Nancy Naples Three negroes by the name of Sarah, Isaac and Jemmy, to her and her Heirs forever--also, one bed Stead, bed & furniture, one large Cupboard, and every thing else not herein named to the said Nancy Naples forever.-----

Also, I give to Mary Wells, One Bed & One Safe forever.

Also, I give to Matt William Terry, One Bed & furniture one trunk forever-----

Also, I give to James Terry Dukes, One BedStead, Bed and furniture One Slab, one Truck &c, upon the same restrictions as I have disposed of Dave to said James Terry Dukes-----

It is my full meaning, & exprefs Will, that all the future Increase of any or all of the above Negroes shall be included with their Mothers in the disposition of my property by this my Will-----

Lastly, I nominate and appoint my trusty friends, Matt^W James and John Gayle as Executors to this my last Will and Testament-- And I authorize and empower my said Executors at my decease to keep the whole of my Negroes together, if it should be found necessary & hire them out untill all my debts are fully paid, and then a Division made as above & within stated amongst my Heires-----as witness my hand and Seal this Twenty fifth day of August in the Year of our Lord, One thousand, Eight hundred and twenty two-----
