Item I give and bequeth unto my Son Ransom Yeats Bonner Daniel the House and plantation where I now live including Two Hundred and fifteen acres the Ballance of the Tract one Bed and furniture

Item I give and bequeth unto my Son Ransom Yeats Bonner Daniel the House and plantation where I now live including Two Hundred and fifteen acres the Ballance of the Tract one Bed and furniture my Bay mare and Colt one Cow and Calf and all my Stock of hogs to him and his heirs forever Execpt what it will take to the hogs to be Suficent for the Suport of my wife Susanna Daniel for one year I also give unto the above named Ransom E B Daniel his mother Susanna Daniel and ElizabethEDaniel a sufficiency of my provision Crop for there Suport one year-----

Item my will and Disire is that the Ballance of my property is not disposed of above be Sold and the Debts Due me Collected and

with all my Just Debts to be paid and the Expences of
Carring this my last will and Testament into Effect and if any
remain over my will is that it be Equally Dividd betwixt James
J. Daniel George W. Daniel Elizabeth E Daniel and Ransom Y B
Daniel my ^{four} youngest Children also my will is that the money arise
ing from my present Cotton Crop be put to the use of Discarging
my debts and Suport of my own family and Schooling of my young-
est Son Ransom Y B Daniel-----

I anomeate Constitute and appoint James J Daniel & George W
Daniel my Executors to Execute and Carry into Effect this my last
will and Testament and I also inpower them to Sell any of the
Legasees of Land and give Rights agreeable to or by the Consent
of them To whom ^{it is} ~~given by this my last will and Testament~~ Re-
voking all other will or wills heretofore By me made but this
only to be my last will and Testament In witness whereof I have
here unto Set my hand and seal this 21st Nov^r 1829
