and if Both die leaving no Issue Lawfully begotten then the

slaves are to descend back into my Estate & ^{be} equally divided

among my Children, and do positively order that-my- the said

negroes rem. in ^r the my Executors hands untill said Children arrives
to years of-Maturity.

Item I give & bequeath unto my Grand son Moses B Witherspoon one

Negro man Nero, and a Bed & furni furniture to his Sister

Elizabeth. my Grand daughter.-----

Item I give and bequeath unto my Grand daughter Jannet English

five negroes named Tamar, July Phily, Tom & Harry and all their

futute encrease to her & her Issue forever--and my riding Chair.

Item I give and bequeath unto Sara Wright one hundred dollars and

Ten shillings Sterling to James Carter & D. Witherspoon And its

my will and desire that the remd^r of my Estate be equally divided

among my five Children-----

I Appoint my four Sons Vis James Bradley Roger Bradley and

Samuel Bradley and Doc Moses Bradley my Ext.^{rs}
