my personal Estate Except ^{Currenacy} One hundred and Seventy five pounds to
be Disposed of as here after Deredcted to be paid to him at the
age of Twentey one years or Day of Marrage-----

Item I give and bequath to my Second Son Ely one fifth part of
my perfonel Estate to be Paid to him at the age of twenty one
years or Day of Marrage-----

Item I give and bequath to my third Son patrick one fifth part of
my personel Estate to be paid To him at the age of Twentey one
years or Day of Marrage-----

Item I give and bequath to my youngest Daughter ^{one fifth}
part of my personel Estate To be paid to her at the age of Eigh-
teen or Day of Marrage-----
