I do hereby appoint Constitute mak and ordain My Friend Col John Moore and John Pyland Executors to this My Last Will and Testament and I do hereby utterly Disallow Revoke and Disannul all other former Will Legacies and Executors and Confirm this to be My Last will and Testament in Witnefs Whereof I have hereunto set my hand and seal this the 25<sup>th</sup> Day September Eighteen Hundred and Twelve
