In the Name of God Amen, I Hannah White formerly of George Town District but now of Sumter District South Carolina being of a Sound and disposing Mind and Memory do this Thirtieth day of November in the year of Our Lord one thousand eight hundred and thirty and in the fifty fifth year of American Independence make this my last Will and Testament in manner and form following, that is to Say-----

First I will that all my just debts and funeral expences be fully paid and satisfied as soon as may be after my decease by my Executors herein after named-----

Item I give devise and bequeath unto my Dearly beloved Daughter Lydia Dozier my negro girl Slave named Sarah together with her future issue to her my said Daughter Lydia and her Heirs forever

Item I give devise and bequeath unto my Dearly beloved Son Leonard White my three negro Slaves named Scipio Scesar, and Ned to him my said Son Leonard and his Heirs forever-----

Item I give devise and bequeath unto my Son Leonard White his heirs, executors, Administrators in Trust for my beloved Daughter Elizabeth Mouzon my four Negro slaves named, Binah, Betsy, Judy, and Sylvia together with their future increase for her my said Daughter Elizabeth Mouzon's use, profit and benefit during her my said Daughter Elizabeth Mouzon's natural life, and at her death to the Child or children of my said Daughter Elizabeth Mouzon who may survive her to them and their Heirs forever -----

Item I give devise and bequeath unto my beloved Son William White my three negro slaves named, Baccus Kate, and Sam to him my said Son William and his Heirs forever-----

Item I give devise and bequeath unto my beloved Grand Sons James S. and Thomas Morritt Dick the sum of Five Dollars each, if de-

erty and in the fifty fifth year of American Independence make
this my last Will and Testament in manner and form following,
that is to Say-----

First I will that all my just debts and funeral expences be full^y
paid and satisfied as soon as may be after my decease by my Exe-
cutors herein after named-----

Item I give devise and bequeath unto my Dearly beloved Daughter
Lydia Dozier my negro girl Slave named Sarah together with her
future issue to her my said Daughter Lydia and her Heirs forever

Item I give devise and bequeath unto my Dearly beloved Son Leo-
nard White my three negro Slaves named Scipio Scesar, and Ned to
him my said Son Leonard and his Heirs forever-----

Item I give devise and bequeath unto my Son Leonard White his
heirs, executors, Administrators in Trust for my beloved Daughter

Elizabeth Mouzon my four Negro slaves named, Binah, Betsy, Judy,
and Sylvia together with their future increase for her my said
Daughter Elizabeth Mouzon's use, profit and benefit during her
my said Daughter Elizabeth Mouzon's natural life, and at her
death to the Child or children of my said Daughter Elizabeth

Mouzon who may survive her to them and their Heirs forever -----

Item I give devise and bequeath unto my beloved Son William White
White my three negro slaves named, Baccus Kate, and Sam to him
my said Son William and his Heirs forever-----

Item I give devise and bequeath unto my beloved Grand Sons James
S. and Thomas Morritt Dick the sum of Five Dollars each, if de-
manded to them and their heirs forever---

Item It is my will and desire that the surplus of my Estate ~~xxxx~~
~~xxxx~~ (Should there be any) which is not already willed be applie^d
to the payment of my aforesaid just debts and should that not be
suffieient then it is my will and desire that my Executors hereⁱⁿ
in after named retain on hire, or hire out, my following Negro

Slaves namely Sarah, Binah, Betsy, Judy, and Sylvia until my ~~just~~
just debts be ^{fully} paid, after which it is my will and desire that my
Negro Slave named Sarah, be givin to my Daughter Lydia Dozier as
here of before stated and that my negro Slaves Binah, Betsey,
Judy, and Sylvia be then delivered to my Son Leonard White in
Trust for my Daughter Elizabeth Mouzon as afore stated and ~~Next~~ to
account to my said Daughter Elizabeth Mouzon annually for the
nett hire of said negroes, Binah, Betsy, Judy, and Sylvia so ~~long~~
long as she my Daughter Elizabeth Mouzon shall live and immediate
ly after her my said Daughter Elizabeth Mouzon's death He my
said Son Leonard shall have the said negroes named Binah, Betsy,
Judy, and Sylvia, together with their future increase divided
between the surviving children of my said Daughter Elizabeth
Mouzon or the descendants of such as may have died, share and
share alike, that is the descendants of such as may be dead to
take the part which their Parents would have taken if alive-----

revokeing all former and other wills by me at any time heretofore
made declaring this and this only to be my last Will and Testa-
ment--In witnefs whereof I the said Hannah White to this my last
will and Testament contained on three sides of one sheet of
paper hereunto set my hand and seal the day and year first above
written
