South Carolina) In the Name of God Amen, I James Bradley of
Sumter District) Salem County, and State & District aforesaid,
Planter, being of sound mind, and memory, and Understanding, do
therefore make this my last will and Testament, in manner, and
form following, (Viz) First and principally, I commit my Soul to
Almighty God, my body to the earth, there to be buried, According
to the discretion of my executors, my estate and Effects, I Be-
queth and dispose of, in manner and form following, After the pay-
ment of all lawful debts-----

Item. I give and bequeath, to my Nephew James Hervey Bradley, Sev-
en hundred Dollars for the use of educating him, to be given by
executors as needed, and if the above named James Hervey Bradley,
should die, before the above sum of Seven hundred Dollars is ex-
pended, the balance to return back, and be dispos,d of as here
after directed--- -----

Item. I give and bequeath to my Cousin David Mitchells Oldest son,
~~William James Mitchell~~, three hundred Dollars for the use of
Educating him, and if the above named William James Mitchell,
should die before the above sum of three hundred Dollars is ex-
pended, to fall to his brother for the same purposes-----

Item. I give and bequeath to my Mother Marg ret Bradley, all the
remainder of my real, and personal Estate, for her use and support,
and at her Death, to be Equally divided between my two Brothers,
Josiah W^m Bradley & Matthew Bradley ^{and} to the heirs of their body,
Allowing mybrothers Matthew Bradley, to draw a sum equal to the
sum expended by James Hervey Bradley---I also Constitute, and
appoint, David Mitchell, Josiah W^mBradley, and Matthew Bradley,
