In the name of God Amen I James Richbourg Sen^r of Sumter district State of South Carolina being in a great weaknes of body--but of perfect Memory do make this my last will a testament & revoking all other wills orforms of wills heretofore made & in manner or form following---that is to say--first & principally I recommend my soul into the hands of God Befeching him to forgive me all my Sins through the merits of Jesus Christ--My Blefsed Redeemer--and my body I bequeath to the earth to be Buried at the dification of my Executors hereafter mentioned--and as to touching such worldly Estate as it has pleased god to blefs me with--I give--Bequeath and Divise of the same in manner & form following --Imprimis--it is my will--request & desire that my Just Debts be first of all be duly paid & discharged-----XXXItem--I give & Bequeath unto my Beloved Daughter Isebla L. Nelfon-one negro Wench by name of Unity & her children Afea & Titus (which was given up to me in the Room of a Wench sold by James Nelson to Hoggs by name Cloea & also a fellow by name Sam) to her the sd Isebella L Nelson. also. I give & Bequeath a negro Wench Sytira all the aforesaid Negroes do I give to her. the sd Isebella L. Nelson during her life & after her death to the lawfull heirs of her Body forever----Item----I give & Bequeath unto my Beloved Daughter Sufanna Terry--three Negroes by name of Tisby--Flona & Dave---also one Negro Santee--during her life and after death to the lawful heirs of her Body forever. Item---I give & Bequeath unto my Beloved Daughter Elizbeth Richbough--two negroes by Name of Orange & Rachel during her life & after her death to the lawfull heris of her Bady forever--Item I give & Bequeath unto my Beloved daughter Mary Gayle--three negroes--Lener July & Rose by name during her life and after her death to the lawful heirs of her Body forever---Item I give to my

my soul into the hands of God Befeching him to forgive me all my
Sins through the merits of Jesus Christ--My Blefsed Redeemer--and
my body I bequeath to the earth to be Buried at the diferetion of

give to her. the sd Isebella L. Nelson during her life & after
her death to the lawfull heirs of her Body forever---Item---I
give & Bequeath unto my Beloved Daughter Sufanna Terry--three
Negroes by name of Tisby--Floma & Dave---also one Negro Santee--
during her life and after death to the lawful heirs of her Body
forever. Item---I give & Bequeath unto my Beloved Daughter Elize-
beth Richbough--two negroes by Name of Orange & Rachel during her
life & after her death to the lawfull heris of her Body forever--
Item I give & Bequeath unto my Beloved daughter Mary Gayle--three
negroes--Lener July & Rose by name during her life and after her
death to the lawful heirs of her Body forever---Item I give to my
Beloved Son Joseph Richbough three Negroes Peter Jim & delia by
name to him the said Joseph during his life & after his death to
the lawful heirs of his Body forever---Item---I give & Bequeath
unto my Beloved Son Danill Dela Richbough--four Negroes by the
name of Damon Schott yellow Dave & Thindal--to him the sd Daniel
Dela--during his life & after his death to the lawfull heirs of
his Body forever--Item I give & Bequeath unto my Beloved wife.

Lovisea Richbough one Negro by the name of Jonas to her during her life & after her death to return & be equally divided Between my two sons Joseph & Daniel--also I give unto my Beloved wife for the use of our Children the house & plantation I now live in --after her death I give & Bequeath the same house & plantation Viz all the lands from the run of Jack Creek Eastward up to themill Creek inclufive up to the second Branch that runs into the mill Creek Sticking a direct East Course from the mouth of the afore sd branch to the boundaries of my lands lying southward & Eastward of the aforead Mill Creek & Jack Creek--do I give unto sd son Daniel Dela Richbough & to his heirs forever--Item I give & Bequeath unto my Beloved son Joseph Richbough to him& his heirs forever--all the lands East of the road from whence it crafses the mill Creek Bound- ing on the south on Daniels North Boundary up the mill Creek & taking all land East of the road--Item I give and Bequeath unto Elizabeth Richbough & Mary Gayle all the lands lying between the sd Road from where it crosses themill Creek north & west of said road & Creek to my utmost extremity--for them & their heirs for ever---Item I give & Bequeath unto my beloved daughter Sussana Terry all lands lying between the Extremities of Mill Creek & Daniels north line from the mouth of second Branch & so up mill Creek to Mrs Nesbitts land to her and her heirs forever--Item I give & Bequeath to my Beloved Daughter in law Dorathy Maples a negro girl by name Hager during her life & after her death to the heirs of her Body forever--also it is my will she get her intire stock of cattle without any interuption whatever---Item-- It is my defire that my two Daughters Elizabeth Richbough & Dorathy Maples have each a Bed & furniture--Item It is my will &

inclusiv up to the second Branch that runs into the mill Creek
Sticking a direct East Course from the mouth of the afore sd branch
to the boundaries of my lands lying southward & Eastward of the
aforead Mill Creek & Jack Creek--do I give unto sd son Daniel Dela
Richbough & to his heirs forever--Item I give & Bequeath unto my
Beloved son Joseph Richbough to him & his heirs forever--all the
lands East of the road from whence it crosses the mill Creek Bound-
ing on the south on Daniels North Boundary up the mill Creek & in
taking all land East of the road--Item I give and Bequeath unto
Elizabeth Richbough & Mary Gayle all the lands lying between the
sd Road from where it crosses the mill Creek north & west of said
road & Creek to my utmost extremity--for them & their heirs for
ever---Item I give & Bequeath unto my beloved daughter Sussana &
Terry all lands lying between the Extremities of Mill Creek &
Daniels north line from the mouth of second Branch & so up mill
Creek to Mrs Nesbitts land to her and her heirs forever--Item
I give & Bequeath to my Beloved Daughter in law Dorothy Maples
a negro girl by name Hager during her life & after her death to
the heirs of her Body forever--also it is my will she get her
intire stock of cattle without any interuption whatever---Item--
It is my defire that my two Daughters Elizabeth Richbough &
Dorothy Maples have each a Bed & furniture--Item It is my will &
desire that grand daughter Margeret Boshers be paid One hundred
Dollars--when she comes of age or marries--Item it my will that
after my debts are paid the following negroes be divide to the
hire that be of age as follows. to my Beloved daughter Sussana
Terry a negro Boy by name of Mixture to her & to her heirs forever
& all my real or personal Estate not mentioned as above are to be
appraised--& all those that are under age to have provision made
for Schooling house & kitchen furniture. Clothing with two good

Horses for the use of the plantation the rest to be equally & impartially divided after every demand is paid----it is my will that the present Crop be sold excepting provision for the use of the plantation & to be equally divided share for share-----

Lastly I nominate confititute & appoint My goods friends MathW James & Henry Richbough Esq^r Executors of this my last will & Testament revoking and Difanulling all other formaer Wills or Wills testaments or testaments hereto fore by me made--acknowledging and declaring this and no other to be my last will & Testament in witnes whereof I have here unto set my hand & seal this twenty Eighth day of August in the year of our Lord One thousand Eight Hundred & three
