I John Cousar Minister of the gospel and resident of lower Salem Sumter District and State of South Carolina being in a weak State of body but of sound disposing mind and memory Yet calling to mind the mortality of my body and knowing that it is appointed to all men once to die do make and ordain this my lest will and Testament as follows -

Item.. I order and direct that all my Just debts be paid.

Item 2.. I give and bequeath to the Congregation of Midway of which I have been Pastor a sum not exceeding Forty dollars for the Special instruction of My Negroes. provided there be annual preaching in the Church if Semiannual half the above Sum and so in proportion the Money to be paid by my Executors to the Elders of Midway Church and their Successiors in Office. the Elders to report to my Executors annually that the Negroes have been instructed according to the above Statement.

Item 3.. I give and bequeath to the Theological Seminary located in Columbia under the Superintendance of the Synod of South Carolina and Georgia Ten Dollars annually untill my son John Shaw Cousar shall arrive at the age of Twenty One Years - Item 4th I give and bequeath To the General afsembly Foreign mifsionary Society Ten dollars annually untill my Son John Cousar shall arrive at the age of twenty One

Item 5 I give and bequeath To the General afsembly Domestic
Mifsionery Society Ten dollars annually until my Son John Shaw
Cousar shall arrive at the age of twenty One

Item 6 . I give and bequeath to my four Sons John Shaw Cousar Andrew Flinn Cousar Archibold James Cousar Richard Nelson Cousar calling to mind the mortality of my body and knowing that it is appointed to all men once to die do make and ordain this my last will and Testament as follows -

Item.. I order and direct that all my Just debts be paid.

Item 2.. I give and bequeath to the Congregation of Midway of which I have been Pastor a sum not exceeding Forty dollars for the Special instruction of My Negroes. provided there be annual preaching in the Church if Semiannual half the above Sum and so in proportion the Money to be paid by my Exacutors to the Elders of Midway Church and their Successions in Office. the Elders to report to my Executors annually that the Negroes have been instructed according to the above Statement.

Iten 4th I give and bequeath To the General assembly Foreign missionary Society Ten dollars annually untill my Son John Cousar shall arrive at the age of twenty One

Item 5 I give and bequeath To the General afsembly Domestic
Mifsionery Society Ten dollars annually until my Son John Shaw
Cousar shall arrive at the age of twenty One

Item 6. I give and bequeath to my four Sons John Shaw Cousar Andrew Flinn Cousar Archibold James Cousar Richard Nelson Cousar the whole of the residue of my property both real and personal to be divided Equally among them when they shall have arrived to the age of twenty One or Married -

I nominate and appoint my Friends Willaim W Bradley and William Shaw my Sons John Shaw Cousar & Andrew Flinn Cousar when legal
they arrive at the age Executors of this my last Will and and Guardians of my Children -

I othorise my Executors to appoint five disinterested freeholders to give off Each Child their proportion of My Estate when they Come of age or Marry without applying to Court for an Order- It is my wish that my Executors give or cause to be given to Each of my Children a thorough English Education and any further Education they may think Proper
