Item, I do give unto my dambter Margaret Francisco the following Negro Slaves Namely, Phebe, and her child Milly, Sam, Billy, and Betty, One Feather bed and Furniture, Item, my will and desire is that all the residue of my personal Estate not above mentioned be sold and the profits arising therefrom equally divided between my Two daughters Elizabeth and Margaret, Item my Will and desire is that the above mentioned Negro Slaves which I have given to my two daughters Elizabeth & Margaret be valued and if there is any leficiency in the valuation of either of themr parts it shall be made up in cash se as to make them of equal value, Item my Will and desire is that my lands be equally divided between my two daughters, Elizabeth and Margaret and to be rented out by my Excutors until they think proper to have it divided, and Lastly my Will and desire is that if either of my daughters Elizabeth or Margaret should die and leave no Legitimate Ifsue at any time of her life, an that
