

WILL OF

JOHN MULLIN

In the name of God, amen, I John Mullin of Sumterville, being sick and weak in body, but of sound and disposing mind, memory and understanding, do make this my last will and Testament in manner and form following, to wit,

First—I give and bequeath unto my nephew Alexander Mullin the sum of Thirty Dollars to be paid to him if my daughter dies leaving no child at her death-----

Second—I give and bequeath unto my Brother James Mullin for the term of his natural life, the work labour and use of a negro man-slave named Tom, upon condition that he Cloth feed house the said negro as if he were his own and paying my Executors hereafter named one Dollar per annum, from and after the death of my said brother James, my will & desire is that the said negro be disposed of as is herein after directed-----

Thirdly It is my will and desired and I do hereby order and authorise my Executors herein after named to sell of at Public Sale all my Real Estate on a credit, taking from the purchaser Bond, payable by equal instalments, at two, three and four years, with Interest from the day of Sale and also a mortgage of the same to secure the payment there of, and that they when they do receive purchase money of my real estate that they do put ^{the} same out at Interest; and that they do yearly hireout all my negroes, taking security for the payment of the hire and that they do sell all other my personal Property and Collect as soon as possible all debts and monies that may be due me at the time of my death and that they do also pay, apply and dispose of the Interest arriving on the amount of the sales of my real estate, the money arriving from the hire of my negroes and such sum or sums of money or Debts as shall be due or owing to me at my death, or so much

of Thirty Dollars to be paid to him if my daughter dies leaving
n child at her death-----

Second-I give and bequeath unto my Brother James Mullin for the
term of his natural life, the work labour and use of a negro man-
slave named Tom, upon condition that he Cloth feed huse the said
negro as if he were his own and paying my Executors hereafter
named one Dollar per annum, from and after the death of my said
brother James, my will & desire is that the said negro be dispos-
ed of as is herein after directed-----

Thirdly It is my will and desirer and I do hereby order and
authorise my Executors herein after named to sell of at Public
ale all my Real Estate on a credit, taking from the purchaser
Bond, payable by equal instaments, at two, three and four years,
with Interest from the day of Sale and also a mortgage of the
same to secure the payment there of, and that they when they do
receive purchase money of my real estate that they do put same
out at Interest; and that they do yearly hireout all my negroes,
taking security forthe paym^t of the hire and that they do sell
all other my personal Property and Collect as soon as pofible
all debts and monies that may be due me at the time of my death
and that they do also pay, apply and dispose of the Interest
arriving on the amount of the sales of my real estate, the money
arrying from the hire of my negroes and such sum or sums of mone
or Debts as shall be due or owing to me at my death, or so much
there of as may be sufficient, for and towards the maintainance,
education, support and bringing up of my daughter Panthia Miranda
Mullin untill she attain the age of twenty one years or marry(If
she so long lives)which ever may first happen, and from and after
my daughter ~~attain~~ arrive of age, marry or die then the daid
negroes, monies, & lands if not sold, to be disposed of as here-
in after mentioned.

Fourthly- I give, Bequeath, and devise unto my daughter Panthia
for her
Miranda Mullin and the Heirs of her body lawfully begotten
life time,
all my negroes including the one above given to my Brother for
his life time, after the death of my brother, also the monies
arising from the sales of my real estate or the said real estate
if not sold as above directed, and all other my personal Property,
to be delivered to her on her arriving of twenty one years of age
or day of marriage which ever may first happen for her life time
and from and after her death, to such children or child as she
may leave at her death, But should my said daughter die leaving
at her death no children or child, then and in such case my will
and desire is that the said negroes, the monies for which my real
estate may be sold or said real estate if not sold as above direct-
ed and other my personal estate, be divided in manner following,
to wit,

To To William L Mullin, two negro men Slaves Tom and Peter and
his heirs forever, To Sarah Mullin one negro woman Slave named
Tena and her Heirs forever. To Susanna Mullin daughter of James
Mullin, a negro Girl named Jude and her Heirs forever. To Mary
Mullin one negro woman named Agy and her heirs forever. To Eliza
Mullin dau daughter of James Mullin, a negro Girl named Amy, &
her heirs forever. To John Mullin son of James Mullin one negro
man named Washington, & his heirs forever. To John Mullin son of
my deceased Brother Edward one negro man named Daniel and his
heirs forever- To Susanna Mullin, daughter of my deceased Brother
Edward, one woman named Jenny, and her heirs forever. To Eliza
Mullin daughter of my deceased brother Edward one negro man named
Jim, and her heirs forever, the rest, residu and remainder of
my estate to be equally divided between William, Sarah, Susanna,
Mary, Eliza and John children of my Brother James and Susanna,

not sold as above directed, and all other my personal property,
to be delivered to her on her arriving of twenty one years of age
or day of marriage which ever may first happen for her life time
and from and after her death, to such children or child as she
may leave at her death, But should my said daughter die leaving
at her death no children or child, then and in such case my will
and desire is that the said negroes, the monies for which my real
estate may be sold or said real estate if not sold as above direct-
ed and other my personal estate, be divided in manner following,
to wit,

To To William L Mullin, two negro men Slaves Tom and Peter and
his heirs forever, To Sarah Mullin one negro woman Slave named
Tena and her Heirs forever. To Susanna Mullin daughter of James
Mullin, a negro Girl named Jude and her Heirs forever. To Mary
Mullin one negro woman named Agy and her heirs forever. To Eliza
Mullin daughter of James Mullin, a negro Girl named Amy, &
her heirs forever. To John Mullin son of James Mullin one negro
man named Washington, & his heirs forever. To John Mullin son of
my deceased Brother Edward one negro man named Daniel and his
heirs forever- To Susanna Mullin, daughter of my deceased Brother
Edward, one woman named Jenny, and her heirs forever. To Eliza
Mullin daughter of my deceased brother Edward one negro man named
Jim, and her heirs forever, the rest, residus and remainder of
my estate to be equally divided between William, Sarah, Susanna,
Mary, Eliza and John children of my Brother James and Susanna,
Eliza and John, children of my deceased Brother Edward and their
heirs forever, share and share alike-----

Fifthly- I nominate and appoint as Guardians to my daughter Panthia
Miranda Mullin, until she arrive of age or marry which ever may
first happen Spencer Wilder and John B Miller, or the one that will
act as such-----

lastly- I do hereby nominate constitute and appoint Spencer
ilder and John B Miller Executors of this my last will and Test-
ament, hereby revoking and making void all former wills and Testa-
ments at any time heretofore by me made and do declare this to be
my last will and testament-----
