In The Name of God Amen. I LeGrand Guerry of the State of S^t. Carolina Planter being very sick and weak in Body but of perfect mind and memory, thanks be Given unto God Calling unto mind the Mortallity of my Body and knowing that it is appointed for all men once to die, do make and ordain this my last Will and Testament, that is to say principally and first of all I recommend my Soul Into the hands of Almighty God that Gave it, and my Body I recommend to the Earth to be Buried in decent Christian Burial at the discretion of my Executors, and as Touching such worldly Estate wherewith it has pleased God To bleſſ me this life I Give devise and dispose of the Same In the following manner and form. First I Give to my dear Wife Sarah The following negroes viz. Paul Patty and Child Ceasar Libo, Jinny Parris Nancy Billy Winder with their Increase also Two horses Jupiter & Flint. and a Plain Chair & harness to be purchased by my Executors as soon as poſſible without Inconvenience to the Estate In Liew of her Dower; It is also my will that my dear wife Sarah Continue on my Plantation with her negroes and have the Use of my Land and Stock and household Furniture during the Term of her /Widowhood and no longer----Secondly I Give all the rest and residue of my Estate Both real and Personal to my Children to be Equally divided Between them Share & Share alike, But Should Either of my children die without Issue my will is that their Portion of my Estate shall return to my Surviveing child or children--- And I Nominate Congstitute and appoint my Three Friends James Guerry Jun^r Gabriel Capers & William Capers Jun^r Executors of this my last Will and Testament hereby revoking and making Void all and every other will and wills at any time heretofore by me made and I do declare this to be my last will and Testament. In Witness whereof I have hereunto Set my hand Seal This Twentieth ----- day of March ANNO DOMINI Eighteen Hundred and Ten
