In the name of God Amen. This the twenty-seventh day of November, in the year of Our Lord One thousand eight hundred and fourteen, I Mary Tock of Sumter District in the State of South Carolina, Being of full strength of Body, mind and memory, Do make, Constitute and ordain this my last Will and Testament. And as touching my worldly goods, wherewith it hath pleased God of his infinite goodness and mercy to endow me in this life, I do give bequeath and dispose of in the following manner and form.

Item, I give and bequeath to my nephew David Jordan (the eldest Son of my Sister Elizabeth) the use of my negroe woman Penny with her future ifsue and increase during ~~his~~ natural life, and at his decease I will and bequeath the said negroe Penny with all her future ifsue and increase to his heirs lawfully begotten, to be equally divided among them Share & Share alike. Item, I give and bequeath to my friend Ann C, Richardson my Bed, boulster & pillows which I use in common, and my plain gold Ring to be accept-

ed by her in remembrance of my friendship. Item, I give and bequeath to my friend Floride B. Richardson my Silver Snuff Box to be accepted in remembrance of me. Item, I give and bequeath to my three young friends the following articles Viz. To Emma S. Richardson The mahogany Bedstead. To Camilla F. Richardson my other feather Bed. and to Anna M. Richardson my matrafs, requesting they would each accept this small donation from their friend. Lastly, I do hereby nominate, constitute and appoint my friends James B. Richardson and Charles Richardson Executors to this my last will & Testament, utterly revoking, disavowing & disallowing all other will or wills, Testament or Testaments by me made, and acknowledging this and no other to be my last will & Testament, contained on these three pages of paper, and to be construed in the liberal & literal sense and meaning.
