Second My Will and desire is that my said Wife shall have all the Land that lies within the Fences that now Stand and run by the springs and round the Orchard taking in the Houses where I now live and extending as far South as the Crop Fence; And further my desire is that she have an additional piece of parcel of Land on the West side of my Lane, so as to Compose in the whole ^{fifty} Acres having lines the run from the corner of the said Crop Fence a due West and from the North Eastern Corner, of ~~the~~ said Orchard or Field a due West taking in the said fifty Acres in nearly a four Square form, And it is my further desire that My said Wife have the Way and Use of both of the Springs that lie East of my said House. To have the said Fifty acres of Land and Way and Use of the said Springs to her and her Heirs and afsigns forever.

Seventh. My desire is that my said Son Nathaniel have one bed and

Furniture belonging to said Bed.-----

Eighth--My Will and desire is that all my Lands (except the said Fifty Acres which I have given to my Wife and also the said Way and Use of the said Springs) be given to my two Sons Richard and Nathaniel to be equally divided between them. And to be held to them and their Heirs and Assigns forever.-----

Ninth My Will and desire is that my Daughter Mary Drake have my Negro Girl Cherry

Tenth My desire is that my Daughter Sarah Rheams have my Negro boy Sam

Eleventh--My Will and desire is that all my Property that is not heretofore given in this Will shall be set up at public Sale, and the Money arising from such Sale shall first go in discharge of of all my lawful Debts including all Funeral expences, And the residue to be equally divided between all my Children.

Lastly. I do hereby Constitute and Appoint my Dear Wife Elizabeth and Alsalom Williams as my lawful Executrix and Executors to Act and do in every respect as this my last Will and Testament directs
