

Seven hundred & Ninety three I Philemon Cabbage of Camden district & State of South Carolina, Being very weak in body but of perfect mind & memory, blefssed be God, & doubting the time of my desolution to be near at hand do give & recommend my Soul to God, my Body to be decently buried, my worldly Estate to be disposed of as follows, Viz My funeral charges & debts to be paid in a convenient time after my death -----

Item: I give & bequeath unto my Daughter Anah one negro Girl named Philis and her Stock of Cattle marked with three fingers & underbit in one ear and a Steplefork in the other Ear together with a gray Gelding her Saddle & bridle her Bed & its furniture half a dozen of Chairs & a looking Glafe to enjoy & posses the same at my decease -----

Item I give & bequeath unto my Daughter Mary the Sum of Sixty pounds, forty pounds of it to be laid out for a negro Girl for my Said Daughter & the purchase to be made as soon as convenient after my decease-----

Item I give & bequeath unto my Daughter Sarah one negro Girl named Clareysey together with thirty five pounds Current money -----

Item I give & bequeath unto my three Sons John , Thomas & William, Banks one negro Woman named Charlotte & all her Increase and a Boy named Jim to be equally divided among them -----

I do hereby authorize my Executors hereafter named to hire out to discreet persons my three Negroes named Cyres Jude & Charlott for the term of four Years for the best price they can get & the money arising therefrom to be disposed of in Schooling & Maintaining my three Sons John Thomas & William Banks -----

I do further authorize my Executors after the expiration of the above four Years to expose to public Auction The above mentioned two Negroes Cyrus & Judee & the Money arising from such Sale to be equally divided among my three Daughters Anah Mary & Sarah -----

Item it is my will & desire that my daughter enjoy their part at the age of Eighteen years or Marriage & that it be Entailed to the

Item I give & bequeath unto my three Daughters Anah Mary & Sarah all the Money arising from the Sale of the remainder of my personal Estate and do hereby Order my Executors to have Such Public Sale within twenty days after my decease giving one Years Credit -----

I do hereby give my Executors absolute power & authority upon receiving full payment of a Bond of one hundred & forty pounds upon Major John Gamble & George Cooper Esquire to make good & sufficient titles to Said Major John Gamble & George Cooper Esq. for two tracts of Land Viz the one wherein I now dwell containing 200 Acres the other Adjoining containing one hundred Acres, both tracts was Originally granted to Charles Storey -----

Item I give and bequeath unto my three Sons John Thomas & William Banks one hundred & forty pounds current money to be equally divided between them at their arival at the age of twenty Years or at their Marriage the Money arising from certain Bond upon Major Gamble & George Cooper Esquire which Money is to be kept at Interest by my Executors -----

I do require my Executors to put my three Son's to trades when they Judge proper -----

I do hereby appoint Capt Thomas McFadden Suten Byrd. Charles Storey James Witherspoon & Jacob Wooters my whole & Sole Executors of this my last Will & Testament & do hereby disallow & disannul all and every other Will & Wills Legacies & bequeaths by me in any ways before this time named willed & bequeathed ratifying & Confirming this & no other to be my last Will & Testament in Witnefs
