Item I give and bequeath to my loving Son Richard Harvin Jun^r three Tracts of land lying on Sammy's Swamp containing Six hundred Acres by original Survey, also one Negroe Man Named yellow George to him and his heirs for ever Item I give and bequeath to loving Son Charles Harvin all my lands lying on Jacks Creek containing Eight hundred Acres more or less, also One Negroe Man Named Solomon to him and his heirs forever Item I give and bequeath to my loving Son John Harvin Eight hundred Acres of Land to be laid off by a line running from a pine corner standing between free Dicks field and big branch to James E Harvins line so as to include the Eight hundred acres before mentioned also one Negroe Women Named Delia to him and his heirs forever.-----Item I give and bequeath to my Daughter Nancy Harvin One house and two lotts adjoining each other in Sumterville where William Scott now lives but in case William Scott Complys with his contract for said house and lotts, then my Daughter Nancy to Receive One thousand Nine hundred Dollars in lieu of said house and lotts, also One Negro Women Named Sarah to her and her heirs forever. Item I give and bequeath to my Daughter Sarah Harvin, Three houses and lotts in Sumterville (Viz) The house and lott occupy'd by Samuel Uddike The house and lott occupy'd by James Caldwell also the house and

lott occupy'd by Daniel Rose also one Negroe Girl Named Nelly to her and her heirs for ever-----

Item, I give and bequeath to my loving Son William R Harvin all the Remaining part of my lands lying and being at Sumter Court house not otherwise bequeath'd, also one Negroe Boy Named Willis to him and his heirs for ever.

Item I give and bequeath to my two loving Sons Thomas and Samuel Harvin at the Death of my Wife Frances Harvin The remaining part of my lands not otherwise bequeath to share and Share alike my Son Thomas Harvin to the upper part adjoining James E Harvin, and my son Samuel Harvin the lower part, also I give my Son Thomas Harvin one Negroe Girl Named Letty and my Son Samuel Harvin one Negroe Boy named Edmond to them and their heirs for ever.-----

Item I give and bequeath to loving Wife Frances Harvin during her Natural life the house and lands I now live on with the remaining part of my personal property not otherwise bequeath'd support and for the Support and Education of my three youngest and after her Death the remaining part of my personal as afore children said to be equally divid between my Children, Vi z) James E Harvin Richard Harvin Charles Harvin John Harvin Nancy Harvin William R Harvin Thomas Harvin Samuel Harvin and Sarah Harvin to them and their heirs forever.

And I hereby make Ordain Constitute and appoint my three loving Sons-----Richard Harvin Charles Harvin and William R Harvin-----Executors to this my last Will and Testament and do hereby revoke Set aside and make void any andall Wills heretofore made by me and declare this to be my last Will and Testament

Codicil

Be it known to all men by these presents that I Richard Harvin of the District of Sumter and State of South Carolina (Planter) Have made and declared my last will and Testament in Writing bearing date the twelfth day of December One thousand eight hundred and Seven I the said Richard Harvin by this present Codicil to ratify and Confirm my said last will and Testament. But do order and direct that one Lott of Land in Sumterville purchased at Sheriff Sale, Sold as the property of John McDonell containing one half Acre, One other Lott lying and being on the North Side of the gaol lott adjoining thereto and East on the main Street containing one half Acre, also one other Lott lying on the East side of the Gaol containing One Acre, being put in the Legacy left to my Son William R Harvin through mistake, be sold to the best advantage by my Executors, the Money arising there from go toward the discharge of my Debts, and my will and meaning is that this Codicil be adjudged to be a part and parcel of this my last Will and Testament and that all things there in mentioned and Contained be faithfully and truly performed and as fully and amply in every respect as if the Same were so declared and Set down in my last will and Testament, Witness this twelfth day of December One thousand eight hundred and Seven
