of ~~all~~ my Plantation where she Know lives If it can be Redeemd
from the Publick also house Hold Furniture and Plantation Tools
also Horses & Cattle except what shall hereafter be Disposed of
Item I give unto my Daughter Mary Billups Eight Cows and Calvs
Item I give unto my son Rich^d Richardson Eight Cows & Calve Item
I give unto my Daughter Dorcas Dow six Cows & clavs Item I give
unto my Daughter Susannah Richardson six Cows & three ^{two old} (Five) Herfers
Item I give unto my Daughter Harnett Richardson nine Cows and Calves
Item I give unto Each of my Children the Horses ~~that they~~ claimed and
ther Increase Item I give unto my son Richard Richardson the above
mentioned negroes Viz old James ^{Manner} his Wife Brutus, Harcules,
Cate Tesby Hannah, Mary to be(cept) together until my Lawful Debts
is paid and at that time old James & Marian his wife to be Freed
Item I give unto my Daughter Darcas Dow one negroe Fellow & wench
named Cirus & Celvey after my Debts is Paid also one other Boy named
Rob all to be kept together untill my Debts is paid Item I give unto
my Daughter Susannah Richards the following slaves Viz Bell & Dorcaf

Darcas Dow three Hundred acres of land part of the (Thirteen) Hundred acre Tract from Wilders towards the Caney Branch in leiw of the Land he was to of had on Savarn Crck Item I give unto my grandson Rich^d R Billups one Tract of Land of Two Hundred & fifty acres Lying near Jacks Crak Item I give unto my Daughter Susannah & Harriot Richardson three Hundred acres apeace of land calld the woodyard Tract unless it shall be found Necefsary for the Executors to sell then other shall be given in place Item I give unto my son Richard Richard all my lands on the High Hill if not sold to pay my Debts my will and Desire is for all the lands Remaining to go to paying ^{My} Debts also my will and Desire is that at my Beloved wife Darcas that the negroes Remaing shall be Eaqually Deivded amongs my son Richard my my Daughter Mary Billups children Darcas Dow Susanah. & Harriot my will is that Incase Susannah or Harriot should die with marriage then the Property to Return to the others aBove mentioned further more my will & Desire is that the aBove mentiond Property, to be kept together of the Executors untill my Lawfull Debts is paid Confirming this to be my last Will and Testament as Witnefs where of I have set my hand and seal this 6 day of September In the year of our Lord one thousand Seven Hundred and ninty Two
