Item I give and bequeath to my three Sons John, Albert, and David Bradley and their heirs forever the remaining two thirds of my Lands to be divided by appeasements equally amongst them Except as my wife is now pregnant Should She be deliverd of a Son then it is my will and desire that he should have an equal share of my lands with my three Afore'sd mentioned sons And at the death of my wife it is my will and desire that the third part of Land left to her Shall be divided in the Same manner as the other two thirds and it is further my will and desire that if one or more of my Sons die before ^{they} they come of age or received their part that the Survivers shall have the deceased part or parts Item it is my will and desire that after paying my just debts and Funeral expence that my personal Estate be equally divided share and Share alike between my wife Martha Bradley and children as they come of age or marry Viz. John Bradley, Albert Bradley David Bradley, Theadocia Bradley, Martha Bradley, Elisa Bradley, Mary Jane Bradley, Sarah James Bradley, and the Child that my wife is now pregnant with Except reserving as much out of my Sons parts of my personal Estate as will make my daughters

my last will and Testament hereby revoking and making Void all and every other will or wills hereto fore by me made and do declare this to be my last Will and Testament. in Witness whereof I have hereunto set my hand and Seal the twenty Seventh day of Dec^r in the 18th year of our Lord Eighteen hundred and Five Signed, Sealed declared, and published by the above named Rodger Bradley as and for his last will and Testament, in the presents of us who at his request and in his presence have Subscribed our names as witness thereto.
