Also, I give and bequeath unto My Daughter Harriot former ly the wife of Ransom ONeall Also My Son John R -- Williams also My Daughter Juliett the Wife of Matthew Ramsey, All the Negroes gave off to them at their time of Marriage which was acknowledged in a deed of gift I gave to them at the death of their Mother, which deed I have acknowledge to be good and for the Several Negro gave of to them, Seperately to them and their Heirs forever. Also I give and bequeath unto my Son Rich. H. Williams the five Negroe which are Named in a Deed of Gift which I gave him for him to dispose of as he sees proper or to him and his Heirs forever Also I is my wish and desire that all the rest of My Negroes and Other Property that I may have at my Decease Shall remain in the Pofsef. sion of my Wife Ann Williams during her life time for her Support and Maintainance and if any Surplus should be remaining from the Crops maid by said Negroes after paying All expenses that may Occu to be decently Buried in a Christian like Manner Without any Tuneral Pomp and with as little expence as may be necessary. Williams the five Negroes which are Named in a Deed of Gift which I gave him for him to dispose of as he sees proper or to him and his Heirs forever Also It is my wish and desire that all the rest of My Negroes and Other Property that I may have at my Decease Shall remain in the Pofsefsion of my Wife Ann Williams during her life time for her Support and Maintainance and if any Surplus should be remaining from the Crops maid by said Negroes after paying All expenses that may Occu I wish such Surplus to go toward paying my Just debts it is also my wish that should there be any Debts prefsing (of my Contracting) after my decease that My Executors hereafter Named, shall Select such property (not allready gave away) as they think can best be spared and Sell it so as to discharge the Same, it is my Wish as lang as My Son Richard H Williams lives with his Mother and Works what Negroes he has I wish them Jointley to be Supported out of the Whole of the Estate which is loaned to my Wife, it is my Wish

and Desire at the Death My Wife Ann Williams All the Negroes with their increase that I have loaned her (should no one be sold for my Debts) be equally divided between my four Children Namely Harriott John Juliett & Richard and to go to them and their Heirs forever.

I do hereby Constitute and appoint my Wife Ann Williams as Executrix and my Two friends Richard Singleton and Willis Ramsey as Executors to this my last Will and Testament. Hereby revoking and Void Making, all and every Other Will or Wills at any time or times heretofore by me made And do declare this to be my last Will and Testament.
