Viz 1st I give and Bequeath to my loving Wife Afnefs The following Negroes (Viz) Tom, Gubbenser, Prince, Felio, Jack, Jim and Genne 2^d I Bequeath unto my Daughter Jane the following Negroes (Viz) Elsy and Hasty. 3^d I Bequeath to my Daughter Eltra the following Negroes (Viz) Esther and Cherry 4th I Bequeath to my Daughter, Louisa, the following Negroes Viz Judy and Lender 5th I Bequeath to my A. lefs Daughter the following Negroes (Viz) Biner and Rose 6th I Bequeath to my Son Isaac James the following Negroes Viz Bill and Murria 7th I Bequeath to my Son Samuel Rembert the following Negroes Viz March and Lige 8th I Bequeath to my son George Gadson the following Negroes Viz Peter and Naro Item It is my desire that each of my Heirs will hold the stock of Cattle they Claim and if there be not an equal number for each, the defficiency to be made up out of my Estate and also that my Heirs will hold the stock of Hogs they Claim.

Item I give my loving Wife aforesaid the Plantation on which I now Live, together with its Improvements utensels &c as I now hold it, except the Bay Mare and Mule, the right of which to remain unto Son Samuel Rembert Item Guerri and Clark's Plantations to be rented by the Executors unto the highest Bidder among my lawful heirs. But the Aligator Bay land to be held by Charles P Chandler during my wife life, and after her decease, the land and negroes, together with all the other property she holds belonging to the estate to be equally divided among my afforesaid ~~heirs~~ heirs Item. I order my executors when any of m. heirs will marry, or when they come to lawful age that a bed with all its necefsaries, and a horse, saddle and bridle to be given to each

Item My negro man Moses I order my executors if Afsistant Willis will give fifteen hundred dollard for him in hand, the executors to give him a bill of sale, otherwise the said fellow to be set up

Item I desire, that one acre of land will be reserved about the grave yard, for the purpose of a burying place, and feasible forever .

Item I constitute, and appoint executrix, and executors, of this my last will and testament hereby revoking all other and former wills
