In the name of God amen I William Moody of Claredon County Sumter District South Carolina being very sick and weak in body but of perfect mind and memory thanks be given unto God calling to mind the mortality of my body and knowing that it is appointed for all men Once to die do make and Ordain this my last will and Testament that is to say principally and first of all I give and recommend my Soul into the hands of Almighty God that give it and my body. I recommend to the Earth to be buried in a Decent Christian burial at the descretion of my Executors not doubting but at the general resurrection I shall receive the same again by the mighty power of God and as touching Worldly Estate wherewith it hath pleased God to blefs me in this life I give, desire and dispose of the same in the following manner and Form---First it is my desire that all my lawful debts shall be paid

Secondly I give and bequeath unto my nephew John Moody a Tract of Land containing One Hundred acres lying between Sammey swamp and Halfway swamp and that my Mother Lavicy Gilbert shall live and have Quiet perseeftion therein during her life- Thirdly I give and bequeath unto my beloved Wife Susanna and Child Sarah all the remaining property such as Negroes, Lands, Stock and household furniture when an Equal divison shall be made of the Estate

commend my Soul into the hands of Almighty God that give it and
