be to God for the same, Do make and declare this my last will and
Testament in Manner following Viz-----

First I give and devise unto my Sister Sarah W Langstaff four
hundred dollars, Two hundred Dollars to be paid out of my present
Crop, and two hundred out of the next Crop-----

Second I give and devise unto my Nephew Thomas Warren Langstaff
Eight hundred Dollars to be paid when he arries at the age of
Twenty Years-----

Third I give and devise unto my Niece Martha E Langstaff a Negro
Girl between the age of Twelve & fifteen years, to be paid when
she is married or at the age of Twenty years-----

Forth I give and devise unto my Aunt Heli Howard Fifty dollars
to be paid out of my present Crop, My will and disire is that if
my sifter Langstaff Thomas W Langstaff Martha E Langstaff or my
Aunt Heli Howard should die before these divides is paid my desire
is that the deceased part shall go to my Brothers Peter and Thomas
Wright----- The above division mentioned to be paid out of
my Estate-----

Fifth I give and devise the residue of my whole Estate both
Real & Personal to be equally divided between my two Brothers
Peter & Thomas Wright, If either of my Brothers should die before
he comes to be of age the surviving to have his part, If both
should die before they come of age their parts to be equally
divided between Sarah W Langstaff and her Children-----

Sixth I do nominate Constitute and appoint William Wright Peter
Wright & Thomas Wright my Executors of this my last will and Test-
ament, In Witnefs wherof I the said William Wright Jun^r have
hereunto set my hand & Seal this 26th day of March in the year
of our Lord 1804--

Whereas I Wm Wright Jun^r of Sumter District and State of South Carolina planter, have made and Duly executed my last will and Testament in writing bearing Date the Twenty Sixth day of March One thousand eight Hundred and four, and thereby given and bequeath the Sum to Four Hundred Dollars unto my Sister Sarah W Langstaff, now I do hereby revoke and make void the said legacy of four Hundred Dollars so given and bequeathed by my Said will unto my Sister Sarah W Langstaff, And do give and bequeath the Said Sum of Four Hundred Dollars unto my Nephew Thomas W Langstaff and my Neice Martha Eliza Langstaff to be equally divided betwixt them when they arrive to the age of Twenty years or get Married, and I do ordain and declare this present writing to be a Codicil to my Said Will and that the Same Shall be annexed thereto and taking as part thereof and do confirm my Said will in every particular thereof that is not hereby altered or revoked in Witness whereof I have to this Codicil Set my hand and Seal this Twent^y Sixth day of May in the yeare of Our Lord One Thousand Eight Hundred & four
