signing and Sealing hereof, of a Sound and well disposed mind
and Calling to mind the mortality of my Body and knowing that
it is appointed ~~all~~ all men once to Die do ~~make~~ ordain and Con-
stitute My Last will and Testament in the following manner---
I desire that my Body be Buried in a plain decent and Christian
manner at the discretion of my Executors hereafter Mentioned
and that my funeral Expenses and Just ~~all~~ may Be paid and Dis-
charged with Convenient Speed after my decease-----

Impimi^s I Give and Bequeath to My Son John Clark all that Tract
of Land Containing one hundred and fifty Acres whereon I now live
the plantation which I Bought of William Hendrix, provided that
he Shall pay or Secure to Be paid unto his five Daughters the Sum
of Seven pounds Sterling apiece then The Said property to Be to
him his heirs and assigns forever-----

Note the above mentioned Sums of money is to Be paid in good
and Sufficent property when th Said Legatees Shall Come to the
age twenty two years as they Shall agree-----

Item My will is that after My decease appraised in property way
By two honest men Chosen By my Executors then to Be Equally
Divided Between My two Children John Clark and Hester Campbell
To Be Exhibited among their Cildren as they See Cause-----

Also I will and Bequeath to my Grandson Henry Clark the
upper Tract of Land Containing one hundred Acres which I Bought
of Charles Emmanuel Theely provided my rights holds the Land With
all the appurtenances thereunto Belonging provided that he
yielding and paying the Just and full Sum of fifty pounds Ster-
ling to the Children of John Campbell and hester his wife in
good and Sufficent property as they Shall be agreed when they
Shall Come to the age of twenty two years, the Same to Be Equally
Divided amongst them, and further my will is that if either of
the Legattes heretofore mentioned die Before they Come to the
age of twenty two years their Legacy Shall Be ~~Equally~~ ~~divided~~

Between their Surviving Brothers and Sisters, But if any Disturbances should arise amongst any of my Legatees Before mentioned My will is that it shall Be decided in a friendly and Christian way By four proper Members of the Monthly Meeting at Cain Creek of the Christian people Called Quakers the Same to Be Chosen By the Said Meeting And he or She that will not abide by their Judgement or Determination shall have no part nor parcel of my Estate Nor Be in any wise Benefited this my will-----
 And I do hereby nominate Constitute and appoint My Said Son John Clark and My Son in Law John Campbell To Be the Executors of this my will and Testament, and My Friend Eli. Cook I have in Trust to See my will performed-----
 Disanuling and Revoking all other wills and Confirming this and this only to Be my Last will & Testament Witnefs my hand and Seal the twenty Secend Day of the Eighth month Called August Anno Domini one thousand Seven hundred and Ninety three-----
 Signed Sealed published pronounced and declared By the Said Henry Clark to Be his last will and Testament in the presence of us wee Being present Believing him to Be of a sound and well disposing Mind and Memory-----
