Viz one Childs part to be divided Equally among my following grand Children Viz Salley Gordan & William Being Children of my Son Benjamin deceased the remainder to be Equally divided among my following Children John Robert Elizabeth Isaac Jarred & Jeremiah Item I give & Bequeath to my Son John one Negroe. Girl named Pat which he has now in possession and no more Item I give & bequeath to my Son Robert one Negroe Boy Named Cato which he has now in possession & no more Item I give & bequeath to my Daughter Elizabeth One Negroe woman Named Pat

Which he has now in possession & no more Item I give & bequeath
to my Daughter Elizabeth One Negroe woman Named Bet with her
youngest Child Named Sal to her her lif and then to her Children.
Item I Give & Bequeath to my Son Isaac one Negroe Boy named
Mark and nomore Item I Give and bequeath to my Son Jarred one
Negroe Boy named Peter and no more Item I give and bequeath to
Jeremiah one Negroe Boy Named Adam & no more Item I give and
bequeath to my granddaughter Salley one Negroe Girl named Rose
which her mother Margret Shal have in possession during her

life and after her Decease the wihoh and her increase to her
Daughter Salley: & No more and Lastly I Do Nominate Constitute
and ordain my two Sons Isaac & Jarred Executors of this my will
and Testament Revoking and Dissennuling all other wil or wills
by me one heretofore made and do declare this only to be my
last where unto I have Set my hand and Seal August y 13 1796
