

The last will and Testament of John Wilson of Union County in the State of South Carolina: Be it known unto all Christian people, whom these presents may Concern, that T. John Wilson Being at the signing, and Sealing hereof, of a Sound, and well Disposed mind, and Calling to mind, the Mortality of my body knowing that he appointe Unto all Men once to die; Do make ordain and Constitute my last will and Testament in the following manner, first, I desire that my Body may be Buried in a plain decent, and Christian Manner; at the discretion of my Beloved wife, My funeral Charges and Just Debts may be paid and discharged with all convenient Speed after my Decease Secondly I give and Bequeath unto my Beloved wife Dinah Wilson all my Moveable property, to have and to hold to her to her for ever, provided, and on condition that she do pay unto my Son John Wilson ~~the sum of five pounds~~ Sterling, and likewise unto my five Daughters; Viz. Mary Spray, Phoebe Hawkins, Esther Furnas, Sarah Hawkins and Hannah Wilson the Sum of five Shillings to each of them, Item, I give and demise Unto my Sons, Seth Wilson and Christopher Wilson three tracts of Land, Containing in the whole four hundred and Sixty four Acres, all Adjoining to the tract whereon I now live, to be divided Between them, According to the line already Run through two of Said tracts, and to be continued the Same Course through the third, which lands I give and demise unto my Said two Sons Seth and Christopher Wilson their heirs and Assigns for ever And it is my will, that my Said two Sons, Seth and Christopher do provide a Comfortable living for my Beloved wife: and it is my will that if either of my above Said Sons Shall die without an heir, the other shall have his part It is my will that if any differences should arise between any of the legacies mentioned in this will, I

tween them, According to the line already Run through two of Said
tracts, and to be continued the Same Course through the third,
which lands I give and demise unto my Said two Sons Seth and
Christopher Wilson their heirs and Assigns for ever And it is
my will, that my Said two Sons, Seth and Christopher do provide
a Comfortable living for my Beloved wife: and it is my will that
if either of my above Said Sons shall die without an heir, the other
shall have his part. It is my will that if any differences should
arise between any of the legacies mentioned in this will, all
differences shall be determined in a friendly way by four honest
men, Chosen by the Religious Meeting of the People Called Quak-
ers, and whoever will not Stand to their Judgement shall Receive
no benefit by this will, And I do hereby nominate, Constitute
and Appoint, my Beloved Wife Executrix, and my Sons Jehu and
Seth Wilson Executors of this My last Will; Disanulling, and RE-
voking, all other wills And Confirming this, and this and this

only, to be my last will And Testament, Witness my hand and Seal
